Texas Government Code Section:

- 551.071 Private consultation with the board's attorney
- 551.072 Discussing purchase, exchange, lease or value of real property.
- 551.073 Discussing negotiated contracts for prospective gifts or donations.
- 551.074 Discussing personnel or to hear complaints against personnel.
- 551.076 Considering the deployment, specific occasions for, or implementation of, security personnel or devices.
- 551.082 Considering discipline of a public school child, or complaint or charge against personnel.
- 551.086 Discussing commercial or financial information received from a business prospect seeking to locate, stay, or expand in or near the District and with which the Board is conducting economic development negotiations and to deliberate the financial offer or incentive of such business prospect.


Education Code Section:

- 39.030(a) Discussing or adopting individual assessment instruments or assessment instrument items.

- (A) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
